TRAFFIC CONTROL ORDINANCE

May 8, 1979

No.1 T 79

ARTICLE I - PURPOSE

This ordinance regulates the operation and use of motor vehicles in the Town of Weston, Windsor County, State of Vermont, in accordance with T 24, S 2291 (4) VSA.

ARTICLE II - OFFICIAL TRAFFIC SIGNS

Section 1 - Disobeying Official Traffic Signs.

It shall be unlawful for any person to disobey the direction of an official traffic sign, except in response to the direction of a Police Officer.

Section 2 - Tampering With Official Traffic Signs.

It shall be unlawful for any person wilfully to remove, injure, obstruct, tamper with or deface any official traffic signs.

Section 3 - Designation of Official Traffic Signs.

Official traffic signs shall include painted instructions on the highway pavement, as well as signs on posts.

ARTICLE III - PARKING RESTRICTIONS.

It shall be unlawful to park motor vehicles where either "NO PARKING" or "FIRE ZONE" is painted on the highway pavement.

ARTICLE IV - SPEEDING RESTRICTIONS

Section 1 -

It shall be unlawful to operate a motor vehicle within the town limits of Weston at a speed greater than the posted limits.

Section 2

The Selectmen shall erect and maintain within the highway limits and at a reasonable distance from the point where such regulations become effective, a sign or signs setting forth the maximum legal speed limit upon such thickly settled street or portion of street. The Selectmen shall also erect and maintain at the end of such thickly settled street a sign or signs designating the end of the restricted speed zone.

ARTICLE V - PENALTIES

Section 1

Summons for violations of Article II, Section 1 and Article IV shall be in accordance with the "Uniform Traffic Complaint" and penalties set by the District Court.

Section 2

A fine of \$5.00 shall be levied for violations of Article III.

ARTICLE V - PENALTIES, continued:

Section 3

Violators of Article II, Section 2, shall be fined \$25.00 plus the cost of replacement of the sign or signs.

ARTICLE VI - ENFORCEMENT

This ordinance shall be enforced by the Vermont State Highway Police and the 1st and 2nd Constables of the Town of Weston.

ARTICLE VII - SEPARABILITY


The invalidation of any article or section of this ordinance shall not invalidate any other article or section thereof.

ARTICLE VIII - EFFECTIVE DATE


This ordinance shall take effect July 7, 1979.
